The Division has issued the renewal of the Onsite Wastewater Treatment Facilities for Domestic Wastewater General Permit (ARG550000) with an effective date of July 1, 2024. If you wish to continue permit coverage under this general permit after June 30, 2024, please complete the online recertification form at <https://eportal.adeq.state.ar.us/> **NO LATER THAN May 31, 2024**. If the facility will no longer be in operation after June 30, 2024 and you wish not to renew your coverage, you must submit a Notice of Termination (NOT) before the expiration date of June 30, 2024. Failure to submit either a NOT or a recertification form by **May 31, 2024 will run the risk of operating without a permit**, which would be in violation of the Arkansas Water and Air Pollution Control Act (Ark. Code Ann. § 8-4-101 *et seq.*), and the Clean Water Act (33 U.S.C. § 1251 *et seq.*).

To access the recertification form, you will need to go online to <https://eportal.adeq.state.ar.us/> and use the Form Finder to find “ARG550000 Recertification Notice of Intent for Onsite Wastewater”.
