Dear Director Keogh:

This letter is written to express my STRONG OPPOSITION to the renewal of the Arkansas NPDES Concentrated Animal Feeding Operations (CAFO) General Permit ARG590000.

This General Permit ignores the basic science, physics, hydrogeology, and transport of feces, urine, and washwater and byproducts that are allowed to infiltrate our highly variable geologic settings in Arkansas and make their way into groundwater, wells, springs, and the surface waters of our state. Among the most egregious omissions of this General Permit is its failure to require characterization of water quality of surface or groundwater prior to permitting of CAFOs, thereby omitting, obfuscating and obscuring the impact that these industrial-scale agricultural facilities have on the hydrologic environment of Arkansas, The Natural State. The current omissions of the General Permit fly in the face of good science, and weaken meaningful questions of concerned citizens, who are taxpayers that rely on the unbiased support of your agency.

Renewal of the General Permit will be to the detriment of our environment and to the citizens of Arkansas and our guests, tourists who support our local economy. Please do NOT RENEW General Permit ARG590000.
