This is to give notice in accordance

Branch of the Office of Water Quality
of the Arkansas Department of
Environmental Quality (ADEQ), 5301
Northshore Drive, North Little Rock,
Arkansas 72118-5317 at telephone
number (501) 682-0648, has made a
decision to not renew the above
General Permit, which is set to expire
on October 31, 2016, under the
National Pollutant Discharge
Elimination System and the Arkansas
Water and Air Pollution Control Act.
The Department made the decision not
to renew this General Permit after an
extensive review of all comments
received during the public comment
period. Only one facility had received
coverage during the five-year term of
the General Permit. ADEQ determined
such limited use was inconsistent with
the intent of a general permit and, thus,
did not warrant renewal.
