and Public Meeting/Hearing
NPDES General Permit
ARR0000000 for Facilities Dis-
charging Stormwater Associated
with Industrial Activity located
within the State of Arkansas

This is an amendment of the
public notice originally published
on November 9, 2013. Only the
first paragraph of the original
public notice has been revised.
There are no changes to the pro-
posed draft permit.

This is to give notice that the
Arkansas Department of Environ-
mental Quality (ADEQ), Water Di-
vision, 5301 Northshore Dr., No.
North Little Rock, Arkansas
72118-5317 at telephone num-
ber (501) 682-0623, proposes a
draft renewal of the general per-
mit for facilities discharging
stormwater associated with in-
dustrial activity located within the
State of Arkansas under the Na-
tional Pollutant Discharge Elimi-
nation System (NPDES) and the
Arkansas Water and Air Pollution
Control Act.

Discharges located within the
State of Arkansas requesting cov-
erage will be authorized to dis-
charge to all allowable waters, as
set forth in General Permit
ARR0000000. All receiving waters
are a Water of the State classi-
fied for raw water source for pub-
lic, industrial, and agricultural
water supplies, propagation of
desirable species of fish and other
aquatic life, and other compa-
tible uses.

A public meeting/hearing will
be held on Friday, December 8,
2013 beginning at 2:00 p.m.
(Central Time) in the ADEQ Com-
mission Room in North Little Rock
at the above address. During the
public hearing, verbal comments
will be accepted, but written
comments are preferred in the
interest of accuracy. In the event
of inclement weather or other
unforeseen circumstances, a de-
cision may be made to postpone
the hearing. If the hearing is pos-
tponed and rescheduled, a new
legal notice will be published to
announce the details of the new
hearing date and comment peri-
od.

Comments and public hearing
procedures may be found at 40
CFR Parts 124.10 through 124.12
and APC&EC Regulation No. 8,
Administrative Procedures. All
persons who wish to comment on
ADEQ's draft permitting decision
must submit written comments to
ADEQ, along with their name and
mailing address. ADEQ will notify
each person who has submitted
written comments and/or re-
quested notice of the final permit-
ting decision. Any interested per-
son who has submitted
comments may appeal a final de-
cision by ADEQ in accordance
with Regulation No. 8. After the
public comment period and pub-
lic hearing, ADEQ will issue a fi-
nal permitting decision.

In addition to the public meet-
ing/hearing on Friday, December
8, 2013, there will be an informa-
tional meeting on Tuesday, No-
vember 19, 2013 at 2:00 p.m.
(Central Time) in the ADEQ Com-
mission Room in North Little Rock
at the above address.
