Arkansas Department of Environ-
mental Quality (ADEQ), Water Di-

vision, 5301 Northshore Drive,
North Little Rock, Arkansas
72118-5317 at telephone num-
ber (501) 682-0623, has made a
decision to reschedule the Public
Meeting/Hearing for the renewal
of the Industrial Stormwater Gen-
eral Permit due to inclement
weather on Friday December 6,
2013.

The newly scheduled public
meeting/hearing will be held on
December 13, 2013 beginning at
10:00 A.M. (Central Time) in the
ADEQ Commission Room in North
Little Rock at the above address.
During the public hearing, verbal
comments will be accepted, but
written comments are preferred in
the interest of accuracy. In the
event of inclement weather or
other unforeseen circumstances,
a decision may be made to post-
pone the hearing. If the hearing is
postponed and rescheduled, a
new legal notice will be pub-
lished to announce the details of
the new hearing date and com-
ment period.

Comments and public hearing
procedures may be found at 40
CFR Parts 124.10 through 124.12
and APC&EC Regulation No. 8,
Administrative Procedures. ADEQ
will notify each person who
has submitted written comments
and/or requested notice of the fi-
nal permitting decision. Any in-
terested person who has submit-
ted comments may appeal a final
decision by ADEQ in accordance
with Regulation No. 8. After the
public comment period and pub-
lic hearing, ADEQ will issue a fi-
nal permitting decision.

Written or electronic mail
comments will be considered if
received no later than 4:30 p.m.
(Central Time) Dec. 9, 2013.
