Dear Mr. Clive,

The 2011 Annual Report and Discharge Monitoring Reports (DMRs) for the above-referenced facility in Industrial Sector B2 of the General Industrial Stormwater Permit were received 1/31/2012. The Annual Report has been determined to be in compliance with the permit requirements. The facility has been identified as having a pollutant concentration above typical storm water runoff values. The following is a list of pollutants and high concentrations which should not be exceeded in the stormwater runoff:

If no report was submitted for a parameter, the Department will automatically assume that the value for this parameter exceeded the benchmark value indicated above.

There are no effluent limitations in the general stormwater permit. The purpose of the general permit is to encourage the industrial sector to find Best Management Practices (BMP's) that can be implemented without being mandated. By relaying this information to the industries, the Department hopes to significantly reduce the overall pollutant concentrations for Industrial Sector B2. Please update the facility's Stormwater Pollution Prevention Plan to include BMP's which will reduce the pollutants in the stormwater discharge.
