The Department has issued the renewal of the Industrial Stormwater General Permit (ARR000000) with an effective date of July 1, 2014. If you wish to continue permit coverage under this general permit after June 30, 2014 (expiration of the existing permit), please complete and return the Recertification Notice of Intent (NOI) included on the back of this correspondence to the address at the bottom of the page or send it electronically to water.permit.application@adeq.state.ar.us **NO LATER THAN June 30, 2014 (11:59 p.m. Central Time)**. If the facility will no longer be in operation after June 30, 2014 and you wish not to renew your coverage, you must submit a Notice of Termination (NOT) and an Annual Report and Discharge Monitoring Report (DMR) for 2013 before the expiration date of June 30, 2014. Failure to submit either an NOT or a Recertification NOI could result in enforcement action.

Permittees who fail to make a written request to the Director to be covered by this general permit by **June 30, 2014 will be operating without a permit** which will be in violation of the Arkansas Water and Air Pollution Control Act (Ark. Code Ann. § 8-4-101 *et seq.*), and the Clean Water Act (33 U.S.C. § 1251 *et seq.*).
