The Department has issued the renewal of the Stormwater Construction General Permit (ARR150000) with an effective date of November 1, 2016. If you wish to continue coverage under this general permit, please complete and return the Recertification Notice of Intent (NOI) included **on the back** of this correspondence to the address below or send it electronically to water.permit.application@adeq.state.ar.us **NO LATER THAN SEPTEMBER 30, 2016.** If the project is complete and you wish not to renew your coverage, you must submit a Notice of Termination (NOT), along with pictures showing that the site is stabilized and that all temporary controls have been removed.

Permittees who fail to make a written request to the Director for coverage under this general permit will be operating without a permit in violation of the Arkansas Water Pollution Control Act (Ark. Code Ann. 8-4-101 et seq.) and the Clean Water Act (33 U.S.C. 1251 et seq.). Failure to submit a NOT or Recertification NOI could result in enforcement action.
