The Department has issued the renewal of the Individual Treatment Facility Discharge General Permit (ARG550000) with an effective date of July 1, 2019. If you wish to continue permit coverage under this general permit after June 30, 2019, please complete and return the Recertification Notice of Intent (NOI) included on the back of this letter to the address at the bottom of the page or send it electronically to water.permit.application@adeq.state.ar.us NO LATER THAN June 28, 2019. If the facility will no longer be in operation after June 30, 2019 and you wish not to renew your coverage, you must submit a Notice of Termination (NOT) before the expiration date of June 30, 2019. Failure to submit either an NOT or a Recertification NOI could result in enforcement action.

Permittees who fail to make a written request to the Director to be covered by this general permit by June 28, 2019 will run the risk of operating without a permit, which would be in violation of the Arkansas Water and Air Pollution Control Act (Ark. Code Ann. § 8-4-101 et seq.), and the Clean Water Act (33 U.S.C. § 1251 et seq.).
