This permit allows the permittee listed above to modify the wastewater treatment system in accordance with the permit application and plans and specifications which were received on June 16, 2017, with all additional information received by July 13, 2017, under authority of the Arkansas Water and Air Pollution Control Act (Arkansas Code Annotated §8-4-101 et seq. and Arkansas Code Annotated §8-4-201 et seq.) and the following terms and conditions.

- 1. The treatment system shall be modified in accordance with the final plans and specifications as submitted to the Arkansas Department of Environmental Quality (ADEQ). In case any statement or representation in the aforementioned documents is found to be incorrect, this approval may be revoked.
- 2. There shall be no deviation from the permitted plans and specifications unless the revisions have been submitted for review and written approval is received.
- 3. Within thirty (30) days of completion of construction, a Professional Engineer (PE) registered in Arkansas shall submit written certification to the Department (Permits Branch of the Office of Water Quality) that the facility has been modified in accordance with the approved plans and specifications.
- 4. This permit is issued in reliance upon the statements and representations made in the application and the plans and specifications. Issuance of this State Construction Permit does not guarantee satisfactory performance of the treatment system. The permittee shall ensure that water quality standards are not violated. Any modifications to the treatment facility necessary to meet water quality standards are the responsibility of the permittee and would require a modification to this State Construction Permit.
- 5. A State Construction Permit for modification of an existing wastewater treatment facility does not constitute an NPDES permit. Issuance of a State Construction Permit for construction or modification of a treatment system in no way guarantees or assumes that an application for an NPDES permit to operate the system will be approved or an NPDES permit will be issued.
- 6. The HCR holding basin must have a pond bottom with a maximum permeability of  $1 \times 10^{-5}$  cm/sec before the start of operation in accordance with the approved plans.
- 7. A complete "Operations and Maintenance (O&M) Manual" of the wastewater treatment system shall be updated by the engineering consultant for the operator's use before the plant is in operation.

Permittee:

- 8. If a construction site will disturb equal to or greater than one (1) acre and less than five (5) acres, the permittee shall comply with the requirements in Reg. 6.203 for stormwater discharge associated with a small construction site, as defined in APC&EC Regulation No. 6. If the construction site will disturb five (5) acres or more, the permittee shall comply with the terms of the Stormwater Construction General Permit Number ARR150000 prior to the start of construction. BMPs must be implemented regardless of the size.
- 9. This facility is located as follows: Latitude: 34° 47' 58.71" N; Longitude: 91° 59' 53.53" W; 2592 Highway 15 North at the Intersection of Interstate 40 and Highway 15 in Lonoke County, Arkansas.
- The receiving waters for this facility are Bayou Meto then into the Arkansas River in Segment 3B of the Arkansas River Basin. The outfall is located at the following coordinates: Outfall 001: Latitude: 34° 47' 18" N; Longitude: 92° 00' 26" W.
- 11. The construction will include the addition of a holding pond downstream of the constructed wetlands to allow for a HCR discharge system. The existing treatment systems are as follows: sanitary wastewater biological treatment plant; stormwater none; Bldg. 736 unregulated process wastewater oxidation, precipitation, and filtration; process wastewater (40 CFR 468 & 471 regulated streams, other process wastewater, and non-contact cooling water) neutralizing agent, equalization tank, pH control with polymers, clarifier, biological treatment unit, filter system, head tank, and ion exchange system.
- 12. Failure to begin construction within one (1) year of the effective date may result in termination of this permit if a request for an extension is not submitted to the Department in a timely manner.
- 13. The permittee must submit notification of the start of construction within fifteen (15) days after construction has begun.
