If additional acreage is going to be disturbed, a new site map indicating the new disturbed area and all requirements of the site map set forth in Part II.A.4.F of the Construction Stormwater General Permit, ARR150000, must be submitted to the Department prior to any activity taking place on the additional acreage.

The Stormwater Pollution Prevention Plan will be located on-site in the construction job trailer.
