David and/or Cynthia,

Fayetteville's Program modification requirements per their NPDES permit's compliance schedule was overlooked until just recently. Attached is a document sent with their required draft submittal "package". This and their draft modified Pretreatment Ordinance was electronically received on 2/19/14. This modification will be added to my backlog for a completeness review and approval.

Specifically required on Page 3 of Part II, Para. 7.a. "The permittee shall operate an industrial pretreatment program in accordance with Section 402(b)(8) of the Clean Water Act, the General Pretreatment Regulations (40 CFR Part 403) and the approved POTW pretreatment program submitted by the permittee. The pretreatment program was approved on April 26, 1984 and modified on July 14, 1998. The Sewer Use Ordinance and the Pretreatment Program have not been modified to come into compliance with the current 40 CFR 403 regulations. <u>The permittee shall submit the Ordinance revisions to ADEQ within twelve (12) months of the effective date [3/1/13] of this permit.</u> The permittee shall submit all other necessary proposed modifications at dates to be determined by ADEQ."

The last sentence of the requirement is not standard language and don't know of its origins.

Regardless, Fayetteville has met its requirement to submit a draft revised Pretreatment Ordinance per their scheduled date for your entry as the "scheduled report due(?) – received date(?)" ICIS data element (pardon my ignorance of ICIS jargon).
