Mr. Torrence:

This correspondence is a follow up to your letter received September 16, 2010 regarding the audit/ assessment. The City of Siloam Springs appreciates the good working relationship and cooperation enjoyed with the Arkansas Department of Environmental Quality.

In reference to the City's letter (Bowman to Drown) dated November 14, 2007, which states "Construction of the improvements is expected to commence in late 2008 and be completed in 2010. At that time a Maximum Allowable Headworks Loading analysis will be conducted and information forwarded to [ADEQ]." The City is currently working with Garver Engineering to set Maximum Allowable Headworks Loading analysis. Construction commenced February 27, 2009 and the contract period of 690 days puts the anticipated completion date at January 18, 2011. When the Maximum Allowable Headworks Loading analysis is complete the City of Siloam Springs will submit it along with the new pretreatment ordinance and program narrative update.

The recommended POTW actions for improved implementation for pretreatment and pollution prevention programs have been reviewed and noted, and information shared with affected local industrial dischargers.
