Ed,

Thank you for the notification. As of March 1, 2016 North Little Rock Wastewater Utility (NLR) will assume the control authority status over Molex, a categorical Metal Finisher regulated under the Federal Pretreatment standards in 40 CFR 433.17.

Molex (ARP001032) will hereby be removed from ADEQ's "Non-Pret. city CIUs reports tracking list".

Your correspondence will serve as notification regarding NLR's control authority status over all non-domestic dischargers which are connected to Maumelle's Suburban Improvement District's sewage collection system.

A non-domestic user survey should be conducted to ensure all non-domestic dischargers to Maumelle's sewage collection system are evaluated as non-significant industrial users or significant industrial users subject to NLR's Pretreatment Program requirements.

Via this email, Molex (Bobbi Roberts, ec'd above) has now been officially notified of this change. Molex is now subject to NLR's delegated Pretreatment Program/legal authority.

It was verbally agreed via a phone conversation with Bobbi Roberts and Molex' consultant P.E. [Andrea Hopkins] on or about 2/18/16, Molex will submit its last semi-annual report to this office "during the month of March (2016)" (copying you) and will fit NLR's schedule of permitting them on April 1, 2016 when NLR's self-monitoring requirements will go into effect.

NLR now has four (4) POTWs with NPDES #AR0020303 as its tracking number. NPDES # AR0033626 will be added to NLR's "covered" POTWs under its Pretreatment Program. While Pretreatment Program implementation/enforcement requirements are not currently in that permit, please submit the same information required under AR0020303's annual Pretreatment Program reporting requirements beginning March of 2017.

[Permit #AR0033262 requires modification to reflect it is also covered under NLR's Pretreatment Program with its inherent annual Pretreatment Program reporting requirements.](#)

This office believes NLR's notification and this correspondence will suffice to ensure all interested entities are aware of the control authority status change and its ramifications.

Subject: Maumelle/Permitted Industry

Good morning Allen,

As you may know, as of March 1, 2016 the North Little Rock Wastewater Utility has acquired and taken over all operations of the Maumelle Water Management's wastewater system. As you are also aware of, Maumelle was not a designated " Pretreatment City". The City of Maumelle has one (1) categorical industry on their system, which is Molex, an data / communication connector manufacturing facility and that is currently being regulated under 40-CFR-433 for their plating processes by the Arkansas Department of Environmental Quality (ADEQ). The North Little Rock Wastewater Utility as a "Pretreatment City" is assuming the "Control Authority" status of this system. We are in the process of issuing Molex a Wastewater Discharge Permit regulating the wastewater effluent discharge under the 40-CFR-433 requirements. This permit will go into effect April 1, 2016. Also, I am wanting to know if ADEQ's (Pretreatment Division) is going to notify Molex, that it is no longer the "Control Authority" and it is relinquishing this Authority to the North Little Rock Wastewater Utility or is it even necessary since we the "Utility" have already notified Molex of these changes?

The North Little Rock Wastewater Utility is also in the process of issuing non-categorical Wastewater Discharge Permits to Cintas, an industrial launderer and Kimberly Clark, a manufacturer of disposable wet wipes. These two (2) wastewater discharge permits will also become effective April 1, 2016.

Will this serve as notice to you...ADEQ, Pretreatment Coordinator, of North Little Rock Wastewater Utility's intentions concerning the industries in the City of Maumelle or do you need something more formal?

Thanks for all your help!...I really appreciate it.
