Mr. Campbell,

Your December semi-annual report was received via e-mail on 1/3/11, reviewed, deemed compliant with the the Metal Finishing standards in 40 CFR 433. There are no further actions deemed necessary at this time.

One caveat regarding pH analysis: There is virtually no "holding time" (15 minutes) for analysis of pH per 40 CFR 136.3. Your regulated wastewater/potable water sampling time indicated  $\sim 3:00$  p.m. on 12/2/10. Arkansas Analytical's report indicated their pH analysis was conducted on 12/3/10 at around 2:00 p.m. Their pH results are null and void for your reporting results. Your certified lab should have made note of this on their report to you.

If you wish to analyze for pH immediately upon discharge of your regulated wastewater, you must obtain an accurate pH meter with calibration records on file. More information regarding pH sampling/calibration can be obtained from ADEQ's lab person, Jane Hurley (cc'd above) at 501.682.0938.
