Kevin,

Your December 2012 semi-annual Pretreatment report was received on 1/10/13, reviewed, deemed complete and compliant with the Federal Pretreatment Requirements in 40 CFR 403 and more specifically the Metal Finishing limitations in 40 CFR 433.17.

Thank you supplying this office with the additional Zn testing results during the last six (6) months as this is a requirement in 40 CFR 403.12(g)(6), "If [EZ Loader is] subject to the reporting requirement in paragraph (e) or (h) of this section monitors any regulated pollutant at the appropriate sampling location more frequently than required by [ADEQ], using the procedures prescribed in paragraph (g)(5) of this section, the results of this monitoring shall be included in the report."

Note: Your chains of custody are not complete and the results from them may not be admissible in a court of law. The sampler's name was not entered into the contract lab's form. The chains of custody have to include all names from sampler to lab to make for a complete chain ("UPS" as the common carrier is sufficient). Please keep this in mind in future reports.

Please keep this information and all Pretreatment related correspondence on file for a minimum of three (3) years per 40 CFR 403.12(o).
