Kevin,

Your revised June 2012 semi-annual Pretreatment Report was received and reviewed.

Since December of last year we've had many phone conversations and e-messages discussing your zinc excursions of the Federal Metal Finishing zinc limitations in 40 CFR 433.17. This office appreciates the work you've put into your corrective action plan to alleviate the zinc violations.

Thank you for the synopsis of analyticals (Section 8 of the semi-annual report) taken over the last six (6) months beginning in December 2011.

From 12/7/11 until 2/6/12 (3 months), your zinc levels were in violation of the Metal Finishing "Monthly Average Not to Exceed" and the "Maximum for any 1 day" limitations.

From 3/14/12 until 5/31/12 (3 months), analytical results of your wastewater showed compliance with the federal limitations.

Under 40 CFR 403.8(f)(2)(viii), "[EZ Loader] is in significant noncompliance [SNC] if its violation meets one or more of the following criteria:

...(B) Technical Review Criteria (TRC) violations, defined here as those in which <u>33 percent</u> or more of all of the measurements taken for the same pollutant parameter during a 6-month period equal or exceed the product of the numeric Pretreatment Standard or Requirement including instantaneous limits, as defined by 40 CFR 403.3(I) multiplied by the applicable TRC (TRC=1.4 for BOD, TSS, fats, oil, and grease, and 1.2 for all other pollutants except pH);..."

EZ Loader met this criteria by exceeding the TRC values <u>50 percent</u> of the 6-month time period from December 2011 to May 2012.

The corrective actions you have taken to alleviate the zinc excursions during the last three (3) months of your semi-annual reporting period has brought EZ Loader back into compliance. There are no further actions deemed necessary at this time.
