Dear Allen:

Herein is an update on the status of Mueller Copper Tube Products, Inc. (Wynne, AR)

As indicated earlier in the June, 2014 update, there is no casting operation at the facility. Further there are no plans for rebuilding the casting operation at Wynne.

The extrusion press had been idled for approximately 18 months prior to October 2014. However, due to a mechanical issue at the sister facility in Fulton, MS, the extrusion press was re-started for a limited duration of time which is not expected to extend beyond 31 December 2014.

The experimental runs of extruding and drawing of Aluminum continue. However, this remains experimental in nature and there have been no concrete decisions on a path forward for this project.

At this time, excluding the press as described above, the only operations are drawing of tube, coiling/straightening, annealing and packaging. All wastewater is being transferred offsite. There has been no discharge to the City of Wynne POTW during the time period of June 1, 2014 – November 30, 2014.
