The following is a written response to the one (1) deficiency discovered during the City of Bentonville's pretreatment program audit / assessment conducted on August 20th through August 22nd, 2013.

Deficiency Noted With Required Action:

None of the three (3) SIU's the City had permitted had a clear/understandable wastewater flow schematic or a good comprehensive process narrative. The City must enforce the Federal Requirements as well as their own Pretreatment Ordinance. The City should require its SIU's to update their schematics to more clearly show the exact sampling point and describe all their wastewater generating operations.

Response:

Floor plans and as-built drawings have been submitted by all SIU's. These plans, when scaled down for filing purposes, are difficult to read. As stated in the paragraph above, new clearly marked documents will be submitted by our SIU's and CIU for greater clarity and understanding. A comprehensive narrative description of the SIU's plant processes, including all materials which are or could be discharged, will accompany the updated schematics.
