Re: Hazardous Waste Notification Requirement under the National Pretreatment Program

Manager or proprietor;

The Arkansas Department of Environmental Quality (ADEQ) is requiring all wastewater utilities in the state of Arkansas, including The City of Bentonville, to notify certain sewer customers of Federal Regulations relating to hazardous wastes. At this time, the ADEQ is specifically requiring notification of businesses who dispose of the following into the City's sewage system: hazardous waste pharmaceuticals, mercury from amalgam, and/or silver from spent film processing wastes. If your business is not involved in the disposal of any of these materials listed, please notify Nancy Busen by completing and returning the enclosed Certification Statement to the City of Bentonville Wastewater Treatment Facility (address listed below) within thirty (30) days of the date of this letter.

If you are involved in the disposal of hazardous waste pharmaceuticals, mercury from amalgam, and/or silver from spent film processing wastes into the City's sewage system and do not have an amalgam separator, silver recovery unit, or system of properly disposing of hazardous waste pharmaceuticals, you may be discharging hazardous waste into the City's sewage collections system and must follow the pretreatment regulations and requirements listed below:

Under the specific pretreatment requirement in 40 CFR 403.12(p)(1), "The Industrial User [non-domestic user] shall notify the POTW [appropriate City wastewater official], the EPA Regional Waste Management Division Director, and State hazardous waste authorities in writing of any discharge into the POTW [City sewage system] of a substance, which, if otherwise disposed of, would be a hazardous waste under 40 CFR part 261."

Under 40 CFR 403.12(p)(4), "In the case of any notification made under paragraph (p) of this section, the Industrial User shall certify that it has a program in place to reduce the volume and toxicity of hazardous wastes generated to the degree it has determined to be economically practical." If your facility does dispose of hazardous waste pharmaceuticals, mercury from amalgam; and/or silver from spent film processing wastes into the City's sewage system, please submit the required notifications to the following:

IN EITHER CASE, YOU <u>MUST</u> NOTIFY YOUR LOCAL WASTEWATER TREATMENT AUTHORITY BY COMPLETING THE ENCLOSED CERTIFICATION STATEMENT.
