Stats.), hereinafter called the "Act", the Arkansas Solid Waste Disposal Code, hereinafter called the "Code", and all other applicable rules and regulations of the Department of Pollution Control and Ecology, hereinafter called "Department", and the following terms and conditions:

- 1. The disposal facility shall be constructed, maintained, and operated in accordance with the final plans and specifications as approved by the Department and in compliance with all applicable provisions of the Act, the Code, and all other applicable rules and regulations.
- 2. This permit shall automatically terminate unless construction of the disposal facility has been commenced within the disposal facility has been completed with all reasonable diligence. The Department shall be extend in writing when the disposal facility has been completed in order that it may be inspected.
- 3. The disposal facility shall be operated by qualified personnel and maintained in good operating condition at all times.
- 4. This permit may be revoked or modified whenever, in the opinion of the Department, the facilities are no longer in compliance with the Act, the Code, and applicable rules and regulations. This permit shall not relieve the permittee, its agents or employees, from compliance with all provisions of the Act and the Code.
- 5. Nothing herein contained shall be construed as releasing the permittee from any liability for damage to persons or property by reason of the installation, maintenance, or operation of the disposal facility.
- 6. This permit is issued in reliance upon the statements and representations made in the application and the plans and specifications and the Department has no responsibility for the adequacy or proper functioning of the disposal facility.

ADDITIONAL CONDITIONS

- 7. This permit shall expire when the approximate 15 acre disposal area described in the final engineering plans has been filled to design capacity.
- 8. Proper preparation of the site shall be supervised and reported in writing to the Department by a Registered Professional Engineer prior to placement of any waste in the landfill.
- 9. Only the eleven waste streams listed in the engineering narrative will be accepted in the landfill.
- 10. A one foot clay liner with a compaction factor of 90% proctor will be utilized and inspected by a Registered Professional Engineer as constructed.
- 11. Non-putrescent waste as outlined (waste stream #1 only) in the engineering narrative will be covered once a week. All other waste will be covered daily.
- 12. As an adjunct to the additional conditions listed above, the permittee is reminded that the provisions of Condition #1 of this permit shall also be satisfied in the construction, operation, and maintenance of the landfill.
