The Division of Environmental Quality Office of Land Resources (DEQ) has reviewed the 2021, 2022, and 2023 Annual Engineering Inspection Reports (AEIRs) for the Green Bay Packaging – Arkansas Kraft Division Class 3 Landfill dated May 13, 2022, under Document Identifier 81935, May 17, 2023, under Document Identifier 84023, and March 7, 2024 under Document Identifier 85171. DEQ acknowledges the reports. This acknowledgment in no way authorizes a change to the facility's permit and does not represent an approval of any proposed changes to the facility that may be detailed within the 2021, 2022, and 2023 reports.

The approved cost estimates for closure and post-closure care are \$1,315,054 and \$127,039, respectively. Pursuant to Part 1 of APC&EC Rule 22.522(a)(10) and Rule 22, Chapter 14, the Green Bay Packaging – Arkansas Kraft Division Class 3 Landfill is required to provide to DEQ an updated financial assurance mechanism at least in the amount of the approved cost estimates. This documentation shall be submitted no later than thirty (30) calendar days from the date of this letter.
