On behalf of our client, Green Bay Packaging Inc., Arkansas Kraft Division (GBP), Promus Engineering, LLC is notifying the Arkansas Energy & Environment, Division of Environmental Quality (DEQ) of the tentative schedule for construction of Cell 6 at the GBP Class 3N Landfill.

Notification of Construction Schedule

This notification is being submitted in accordance with 8 CAR § 60-428(f). The liner system construction is planned to begin in the fourth quarter of 2025 and is anticipated to take approximately 3 months. Construction will commence upon approval of the revised CQA Plan, which is currently under review by the DEQ. This schedule is considered tentative and may change due to weather delays. Construction of Cell 6 will generally consist of installing approximately 4.5 acres of bottom liner system.

Below is a list of companies that will be coordinating construction activities during construction of Cell 6.

The earthwork contractor has not completed and documented more than 500,000 square feet of clay liner during the last three years and as a result, will be constructing a portion of the bottom liner system of Cell 6 to satisfy the test fill requirements described by 8 CAR § 60-428(c)(11) and the Construction Quality Assurance Plan. A construction documentation report will be submitted to the DEQ, in accordance with 8 CAR § 60-428(i), following completion of Cell 6.
