A determination has been made that your pre-application for a modification of Site 3 and Site 4 at the Tontitown Class I Landfill is administratively complete. Although your pre-application is administratively complete a metes and bounds description for the boundaries for the area to be modified should be submitted in addition to that of the overall site.

NOTICE OF PUBLIC MEETING
