
The ADEQ - Solid Waste Management Division issued three general permits on February 15, 2006 for the construction and operation of solid waste transfer stations and yard waste compost facilities. These permits have covered your facility for the past five years and are set to expire on February 15, 2011. SWMD is currently preparing to make public notice of "new" general permits which will replace the current permits, but these new permits will not be finalized before the expiration of the "old" permits. In accordance with APC&EC Regulation 22.308(d) and (f), ADEQ hereby extends the expiration date of the old TS and CY permits until such time that the new permits go into effect and provides the attached addendum. The following permit expiration dates are extended:

0000-TSW-MC (SWMD tracking number series 0000-STSW-MC);  
0000-CYW-MC (SWMD tracking number series 0000-SCYW-MC).



In the interim period, new facilities will be required to apply for an individual Type TS or CY permit or wait until the new general permits go into effect.</p>
