City of Forrest City Compost
Operating Plan

- Type Y facilities shall have a written operating narrative that addresses the components of Regulation 22.804(8)(i).

The city of Forrest City's Compost facility is located at 3300 Hwy 334 in Forrest City, AR. Public dumping is not allowed at the facility. All material that goes into the facility is taken by city employees in city vehicles.

- Wastes received at the Forrest City Facility are wood chips and leaf materials.
- The city of Forrest City has three licensed operators, one master and two apprentices, who are designated as being responsible for operation, control, and maintenance of the facility. The master license holder is Floyd Patton and the two apprentice license holders are George Rooks, and Interim Mose Metcalf.
- The method for controlling waste received is having the facility closed to the public and allowing only city workers to bring in waste. City employees are trained and supervised to bring in only chips of wood and leaf materials.
- The city of Forrest City's methods of removing and recovering non compostable materials for recycling or disposal including removal, storage, and disposal of any hazardous wastes: all material is collected by trained employees. Employees collect wood and leaf materials only. Upon initial pickup employees separate non compostable debris from the wood and leaf material collected.
- The city's methods to minimize, manage, and monitor odors; runoff and NPDES storm water control measures is to use a bulldozer/frontend loader to turn wind rows. The temperature of the rows is tested each week to prevent fires. The city also documents each load of chips and leaves daily and each empty truck that leaves the landfill. Typically, about once a month run-off water is collected and sent off to be tested for leachate and other pollutants. There is an allocation for the purchase of a compost spreader and tractor in the 2014 budget.
- Description of the compost method to be utilized the composting material (wood chips and leaf material) is stored at the Forrest City landfill. The material is turned and mixed with the use of a frontend loader and track loader bi - weekly.

1. **Plans for marketing or distribution of the finished compost** – The facility is open the first Saturday of each month to give the public an opportunity to pick up compost materials. The time is posted in the local newspaper and announced on the local radio station each month.
 2. Please verify the facility meets the location restrictions and siting requirements of Regulations 22.803. The facility is located on Hwy 334 and is more than 10,000 feet from any runway or airport.
 3. Please provide the design requirements listed in Regulation 22.806(a)
The facility has gravel roads and the facility only receives material collected by trained city employees and is turned bi weekly in order to cure material.
 4. Please discuss the recordkeeping and reporting requirements of Regulation 22.808(a) and (c) (1).
Storm water is collected and sent off for testing. Monthly load reports are recorded and available.
 5. Please provide a closure plan that meets the requirements of Regulation 22.804(9).
The only waste the City of Forrest City receives is yard waste (leaves and wood chips). The city will notify ADEQ in writing prior to closure of the site. The left over material will be given away before closure and any remaining material will be spread and monitored.
 6. The NOI did not provide a detailed cost estimate for closure. Please provide closure and financial assurance calculations in accordance with Regulation 22.810
The City of Forrest City will notify ADEQ in writing 60 days prior to the proposed facility termination/closure date.
