Re: NABORS Landfill - Leachate hauling and management

Dear Ms. Leslie Davis:

The Arkansas Department of Environmental Quality - Office of Land Resources (ADEQ) respectfully wishes to inform Harbor Environmental (Harbor) of the transition of leachate hauling from Kolb Grading LLC (Kolb) to Harbor. This transition will help all parties move closer to construction project closeout by relieving Kolb of the responsibilities of hauling leachate effective May 31, 2018. Harbor will take over effective June 1, 2018. All information received by Kolb from the hauler, with a haul date after June 1, 2018, will be submitted to Harbor for tracking and management of the leachate hauling. ADEQ requests one additional item, not on the approved scope of work, which is one (1) trash pump to be provided on-site on or before June 1, 2018 for the hauler to pump leachate from the storage tanks into the haul vehicle.

Please note, Kolb will continue to control the leachate pumping stations to support the construction project. Harbor will be notified in writing when to assume control of all leachate pumping stations as outlined in the approved scope of work. ADEQ is offering this work under state contract# 4600037744 and will be for a time period as needed by ADEQ.
