## Eco Vista Fire Timeline 9/13/22 to 9/14/22

- Operators left Eco at 07:07pm. No issues noted
- Steve Peck left at approximately 08:10 pm. He noted no issues.
- Hauling company technician notified of fire in class 4 at 10:03pm
- TFD arrived around 10:15pm.
- Wesley Emerson and Miguel Oropeza arrived approximately 10:30pm
- Fire extinguished and TFD left Eco by midnight. TFD sprayed less than 2,000 gallons of water. Fire was extinguished by site personnel
- Miguel and Wesley remained on site during the night.
- Due to fire, class 4 workface moved from south slope back to north pad. Operations resumed around 08:30am.
- TPD Capt. Josh Bowen and TFD Chief Mark Ramsey arrived to inspect site at 08:58 am. Fire remains suspicious in nature, but difficult to prove without camera footage.
- Jason Guilky with ADEQ arrived and inspected site from 12:15pm to 02:00 pm
- Jason plans on returning on 9/15/22 for final inspection of clean up.
