CITY OF TONTITOWN, WASHINGTON COUNTY, ARKANSAS

A RESOLUTION EXPRESSING THE INTENT OF THE TONTITOWN CITY COUNCIL RELATED TO THE ECO-VISTA CLASS 1 AND 4 LANDFILL EXPANSIONS IN THE CITY OF TONTITOWN, ARKANSAS.

WHEREAS, Eco-Vista, LLC ("Eco-Vista") owns and operates a Class 1 and Class 4 Landfill ("Landfill") which is located within the municipal limits of the City of Tontitown ("Tontitown") and Tontitown has been considered a "Host Community" pursuant to Arkansas Department of Environmental Quality ("ADEQ") Regulation 22.204; and

WHEREAS, Eco-Vista desires to expand the Class 1 and Class 4 Landfill and has been engaged in a process through the ADEQ for said expansion of the Landfill; and

WHEREAS, on July 3, 2018, the Tontitown City Council adopted Resolution No. 2018-07-797-R accepting the location of the proposed Landfill expansion; and

WHEREAS, on November 6, 2018, the Tontitown City Council adopted Resolution No. 2018-11-815R to approve a future land use and master street plan, called the "Vision Plan", which identified the current Landfill site as a future use of "LE-Landfill Exclusive"; and

WHEREAS, on July 7, 2020, the Tontitown City Council adopted Ordinance No. 2020-7-892 to establish an Exclusive Use provide for a zoning district called "EU-L Exclusive Use-Landfill" which included various zoning regulations which would apply to any new landfill use in the City; and

WHEREAS, on October 6, 2020, the Tontitown City Council adopted Ordinance No. 2020-10-900 to rezone approximately 417.1 Acres of the Landfill property from R-MH and R-1 zoning districts to EU-L, Exclusive Use-Landfill; and

WHEREAS, in the fall of 2021, the Landfill received Large Scale Development approval from the Tontitown Planning Commission for the Landfill expansion project; and

WHEREAS, since the approval of the above resolutions and ordinances, the Tontitown City Council has become aware of continuous problems and issues related to the Landfill operation that cannot be regulated by a municipality under Arkansas law, with such problems and issues affecting the health, safety and welfare of the residents surrounding the Landfill and others in the city; and

WHEREAS, the Tontitown City Council is aware that such problems and issues related to the Landfill operation which have occurred with regularity over the course of the past number of years include, but are not limited to, loud noises, debris, serious air quality concerns including noxious gases and odors, pollutants in the ground, water quality issues and other issues; and

WHEREAS, these problems and issues have been communicated to proper regulatory authorities and Eco-Vista by citizens and others, but to date have not been mitigated or addressed; and

WHEREAS, the Tontitown City Council is aware that growth in the region and the city is robust and more people will be negatively impacted by increased Landfill operations; and

WHEREAS, the Tontitown City Council acknowledges that the city has become administratively burdened through the receipt of continuous complaints regarding Landfill operations; and

WHEREAS, the Tontitown City Council acknowledges that a municipality has a significantly limited role in the regulation of Landfill operations, but believes it is necessary to protect the health, safety and welfare of the citizens of Tontitown by affirming to regulatory authorities that the Tontitown City Council, to the extent possible, desires to express its belief that the approval of the expansion of the Landfill will be detrimental to the public health, safety and welfare; and

WHEREAS, the final decision for the expansion of the Landfill has not been made; and

WHEREAS, after thorough consideration of the above, the City Council has determined that the location of the Landfill expansion gives rise to concern for potential limitations to the City's opportunity for growth and desires to withdraw their support of the Landfill expansion in order to protect the best interest and benefit of the citizens of Tontitown.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Tontitown, Arkansas:

Section 1. It is hereby the express desire of the Tontitown City Council, for the reasons set forth above and to the extent possible, that the final approval of the Landfill expansion be denied, or in the alternative delayed until such issues which are negatively affecting the health, safety and welfare of the community can be investigated and addressed by the appropriate regulatory authorities.

Section 2. The Mayor or her designee is hereby authorized to bring this Resolution to the attention of the regulatory authorities and to provide information to such regulatory authorities as is requested or necessary.

Dear Mr. Jones:

I am very concerned about that the citizens of Tontitown and the lack of respect that has been shown to them over the last three years regarding the air and landfill environment. Up until a few years ago, I never heard any complaints from area residents and now I hear criticism weekly. This population has been diplomatic and asked for reasonable requests. They want to see that compliance issues are addressed such as: consistent daily cover, noxious fumes, leachate issues with water runoff, constant noise issues, and trash cleanup. All have repeatedly been given token action without long-term positive outcomes. Due to these repeated complaints, I would ask that the request for the permit be denied and a short-term conditional use permit with measurable time sensitive outcomes be issued.

A conditional use permit with restrictions based on the following would be allowed in a Class I and Class IV area if:

1. Only construction waste were allowed at this landfill with no paint, tar, asbestos or liquid chemicals etc. permitted as these are hazardous waste items (Class IV).

2. The noise issue is addressed immediately with no excuses for breaking these ordinances (Class I).

3. Daily cover rules are adhered to so that at any time citizens could fly a drone across the property (Class I).

4. There is an effort to honestly address the gaseous issues and publicly publish the results of the actual compounds in the gases released in the air (Class I).

Eco Vista Landfill has stated that the landfill is an essential piece of the infrastructure in Northwest Arkansas and approving the Class I and Class IV expansion is important to our growing region. Therefore, it is imperative that

measures be taken immediately to secure the quality and safety of Tontitown's citizen's health and Eco Vista Landfill's viability.

To Whom it may concern,

The City of Tontitown would like to strongly opposes the class 1 and the class 4 expansion of the waste management landfill, located on Arbor Acres Avenue in Tontitown, Arkansas.

Eco Vista desired to expand the Class 1 and Class 4 Landfill and had been engaged in a process through ADEQ.

On July 3, 2018, the Tontitown City Council adopted a resolution accepting the location of the proposed landfill expansion. This was before the toxic gasses were harming citizens.

In 2019 and 2020, citizens started having headaches, feeling nauseous and complaining of various health issues from the emissions coming off the landfill. Citizens came together and started attending the planning meetings, committee of the whole meetings and the city council meetings, as well as meeting with Eco Vista management, voicing their concerns. They made it very clear that there were problems surrounding the landfill.

In March 2021, citizens felt as if they were being ignored by the Tontitown city officials. Citizens had a petition drawn up asking the city officials to STOP THE EXPANSION of the landfill. There were over 1,400 signatures.

The previous mayor threatened planning members that if they did not vote for the expansion that they would open themselves up to being sued. He bullied and threatened them even on the day of the vote. Which he was not supposed to speak at the **Planning Meeting**.

His threating and bulling worked. In the Fall of 2021, the landfill received Large Scale Development approval from the appointed <u>Tontitown Planning Commission</u>. NOT the <u>Elected City Council Members</u>.

The Tontitown City Council, which is above the Tontitown Planning Commission, never voted on the expansion of the landfill at that time. Many of the city council members were shocked that they did not get a vote.

When I was elected in May of 2022, I had the Tontitown city attorney prepare a resolution for the final approval of the Landfill expansion to be <u>denied</u>. The Resolution No. 2022-11-1017R was presented to the Tontitown City Council on November 1, 2022.

The Resolution to deny the expansion passed unanimously, by the ELECTED CITY OFFICIALS.

The landfill is surrounded by a growing residential community. Because of this, there have been multiple issues.

Citizens are complaining of odor, gasses and toxic fumes being emitted in the air causing headaches, dizziness, nausea, burning eyes and other health symptoms, which are very concerning. What is going into the water and soil? Details that have come to light are deeply concerning for our area's environment. Including the surrounding waterways, soil, and air quality. Due to the Karst formation, environmental hazards could reach miles beyond our city limits.

Our health is important. I hope you take this into consideration. We must live with this daily.

There is mud everywhere. On surrounding houses and roads. We live with trash and other debris in our yards and roads causing flat tires and broken windshields. Waste management has repeatedly failed to abide by the guidelines and laws with no ramifications.

Currently waste management would not be allowed to put a landfill in this area. So, why would you allow an expansion?

Citizens of Tontitown no longer want a landfill in this location.

NO EXPANSION to the Waste Management Eco Vista Landfill in Tontitown, Arkansas.

To whom it may concern,

When the latest expansion of WM came before planning, I feel the Tontitown planning commission was misled on the process and may have even been manipulated into making a decision against its better judgement. I will list below instances that may have persuaded a decision for approval.

1.) A special work session was held prior to the vote for a broad range of topics. One topic being the WM expansion. In this work session, I feel like "scare tactics" were used to influence decisions. The meeting included our city attorney, planning commissioners, as well as a few others. We were told that if we voted "NO" we could be held personally liable. At that point, I even called out the fact that I thought this was "scare tactics."

2.) After the meeting, I was told by the previous Mayor that if I voted against the expansion, WM was planning on filing suit against me personally because of my relationship with Angie Russell, who is my aunt. My response was that I had nothing to gain from either a yes or no vote and that her nor the former mayor would influence my decision in any way. His response was that it wasn't a threat, he was just letting me know what the course of action would be.

3.) We were also under the impression, that planning commission's approval vote would go on to city council for final approval. This turned out to not be the case. When we discovered, that this expansion request would not go to city council, I asked the planning chairman, why not? He said he wasn't sure why it didn't and that he thought it would go to city council as well.

I want to be clear, at the time of the vote, none of the above persuaded or influenced my decision. However, it could have very easily influenced other members. I felt at the time, that the code we had previously added was a compromise between the citizens of Tontitown and WM. Since the passing of the expansion, I feel WM has over promised and under-delivered. The problems seem to be getting worse, not better. The relationship between the citizens and WM has become damaged beyond repair.

I am in full support of ADEQ's **DENIAL** of WM permit for expansion until specific criteria revolving around air quality has been met to the satisfaction of the **CITIZENS OF TONTITOWN**.

To Whom It May Concern,

I serve on Tontitown City Council, representing Ward 3, where the Eco-Vista landfill is located. On November 1, 2022, we, as the Tontitown city council, unanimously passed a resolution withdrawing our support of the expansion of Waste Management's Eco-Vista Class 1 and Class 4 landfills.

I sent an email to Mr. Nick Jones on November 4. Please refer to that letter for more information regarding Waste Management's long-standing habit of skirting or ignoring municipal ordinances meant to protect the health, safety, and comfort of Tontitown's citizens. My earlier letter mentioned how the Eco-Vista landfill is built on a Karst formation, which could easily create an ecological, environmental, and medical disaster on par with Flint, Michigan and Hinkley, California. In this letter, however, I'd like to focus on the political malfeasance in Tontitown surrounding Waste Management's expansion efforts at the Eco Vista site.

I was appointed to Tontitown City Council on October 20, 2020 as a replacement for Tommy Granata, after his sudden, unexpected death on August 29, 2020. Paul Colvin was serving as mayor at the time and, likely, knew Arkansas municipal code regarding how to fill a council member vacancy. Even if he didn't know the rules, he, or the city attorney, Justin Eichmann should have consulted the code. As you know, ignorance of the law is no excuse.

AR Code § 14-43-411 (2018)

(a) (1) (A) Whenever a vacancy occurs in the office of council member in a city of the first class having a population of less than twenty thousand (20,000) according to the most recent federal decennial census, *at the first regular meeting after the occurrence of the vacancy*, the city council shall proceed to elect by a majority vote of the remaining members elected to the council a council member to serve for the unexpired term. [emphasis added]

Notice that the Arkansas code was broken when the vacancy wasn't immediately filled. The first regular meeting after the vacancy (Mr. Granata's passing) was held September 1, 2020. Not only was the code broken when the position wasn't filled on September 1, 2020, but the vacancy remained unfilled at the subsequent meetings of September 15, and October 6. I'm certain that was deliberate. I fully believe Mr. Colvin wanted the Rezoning of Waste Management's Eco-Vista landfill (on October 6, 2020) to proceed unhindered. After all, he couldn't be certain who would fill the vacant seat.

I was in attendance at the October 6 City Council meeting. Mayor Colvin was chairing the meeting. Video of the meeting is available for you to view on YouTube by clicking this link: <u>https://youtu.be/5qDkU91gpo4</u>

In the aforementioned video, Mayor Colvin addressed Tontitown citizens who had attended the meeting, presumedly to speak out against the Eco Vista expansion and the widening of landfill's roads. He made a series of statements that, in retrospect, seem less than truthful:

At 6:56, Mayor Paul Colvin stated, "... The council is not voting on *expansion of the landfill* here tonight..." [emphasis added by me]

At 7:08, Mayor Colvin avowed, "...so, I will make all of you that promise that there will be no votes here tonight on *expansion of the landfill*..." [emphasis added]

At 7:52, regarding Waste Management, the Mayor said, "... and that's what the applicant has applied for. They haven't applied for *expansion* or street widening..." [emphasis added]

In the same video, at 12:14, during the citizen comment section of the meeting, a woman named Ashley Baumgardner, posted a question that was read by Courtney McNair: "When will the vote be?" Her question went unanswered.

In the October 6, 2020 Tontitown City Council meeting, the council voted on "An Ordinance Rezoning Approximately 417.1 Acres of Real Property Located at 2210 Waste Management Dr., in the City Limits of Tontitown Arkansas From R-MH, A, AND R-1 to EU-L, Exclusive Use Landfill. The ordinance was presented to the sitting city council members as simple rezoning from Residential Mobile Home (R-MH), A (Agriculture), and Single-Family Residential 1, with minimum lot size of one acre (R-1) to Exclusive Use Landfill (EU-L). The council and the crowd had already been promised that this would have nothing to do with expansion of the landfill, so the ordinance passed unanimously. Several months later, in August 2021, when the Tontitown Planning Commission was preparing to vote for the landfill expansion, they were told in a workshop (August 24, 2021) that if they voted against the expansion, they would be sued, personally. Three members of that commission have told me, personally, they felt scare tactics were being employed by Mayor Colvin and Justin Eichmann, the City Attorney. Interestingly, that workshop wasn't recorded on audio or video.

On August 31, 2021, the entire planning commission voted to approve the Preliminary Large Scale Development request to allow the Eco-Vista Landfill to expand. Perhaps, none of the planning commissioners were bullied into voting yes, but three of those commissioners have expressed, privately to me, regret for their vote and anger for the way they were treated by then-mayor, Paul Colvin and our city's attorney, Justin Eichmann.

Even months before the Planning Commission vote on August 31, 2021, we, on City Council, were told we would have an opportunity to vote for, or against, the landfill expansion, but for some reason were never given that opportunity. The planning commission was also told that City Council would have the ultimate approval. One commissioner remarked on video after the voting on August 31, "...my heart was a 'no'...keep fighting, talk to your city council members." This issue never came back to city council—we never had an opportunity to vote for, or against, Waste Management's proposed expansion outlined in the "Preliminary Large Scale Development Request". Many of us on city council feel that we had been misled, marginalized, or outright deceived. Thus the need for a resolution withdrawing our support for the expansion of Waste Management's Eco-Vista Class 1 and Class 4 landfills, mentioned at the top of this letter.

Earlier this month, ADEQ was kind enough to allow citizen comments regarding this expansion. Numerous residents spoke against the Eco-Vista landfill expansion. Only three people spoke supporting the expansion. One, Mr. Steven Peck, works for Waste Management. If Waste Management suffered a financial setback, he would, no doubt, experience personal negative effects. Former Boston Mountain Director Maylon Rice, who was fired as director after allegations of wrongdoing surfaced, also spoke on behalf of the landfill. I'm not sure what he might gain from the Eco-Vista expansion, but he most certainly has some skin in this game. Boston Mountain's Board has always had a vested interest in having the landfill in our backyard, not theirs. Lastly, former Tontitown mayor Paul Colvin spoke in support of the landfill. Mr. Colvin resigned suddenly last December as allegations of wrongdoing swirled around the city. Historically, there have been rumors of a tit-for-tat relationship between Colvin and Waste Management for years. I couldn't make any speculation on whether or not any of the rumors are true, but it's possible his support goes beyond a desire for a local place to send his garbage. Regardless of the exact reasons, the possibility exists that these men may have some material interest in an approved expansion. Notably, none of them live anywhere near the landfill. In light of this email, and the strange behavior, misdirection, and literal law-breaking involved, Paul Colvin's actions, both as mayor, and now, leave more questions than answers.

We, as members of the City of Tontitown City Council have made our desire clear. Please deny this expansion unless, and until, you can, as fiduciaries of Arkansas' environment, guarantee the health, safety, and well-being of our citizens. Side deals and shady politics have put the interests of Waste Management and the surrounding towns, above our citizens for far too long. With your denial of this expansion, we can start the long road to restoring the trust, and protecting the health, of our people.

Dear Mayor Russell and Representative Robin Lunstrum,


I would like to address the effects on myself, my family and citizens in our area. We live directly North on the west side of Pianalto Rd. On many occasions we have been overwhelmed with a strong gas/vapor smell coming from inside the landfill. We have tracked it back to the inside property lines many times. We also experience trash and debris with a strong our trash smell and or a rotten egg smell at home that is not macabre from the gas line on the very west property line. this has been so bad we have not been able to use our yard that is 3 1/4 acres for entertaining. We had several children and adults from Kenya here and they could not enjoy our yard as it was in there were the worst things I've ever smelled and they are orphans that live around this in much worse conditions. get at times I've been so strong it has over taken the interior of our home and we in the past have had the fire department come out because it was so bad. We get symptoms such as instant headaches nausea vomiting and irritation to our skin. This would not be here if the landfill were not allowed to break rules with coverage and required to protect the citizens.

While on planning commission we had a work session where we were told we had to stay within the guidelines that was presented to us and that if we did not vote within the guidelines we were told we could be sued and would not be protected by city attorney as well we could be sued as individuals. We were told that the city engineer would get everything to the point all we needed to do was vote and that because it was done that way we were required to vote yes to be in the guidelines. We were talk to you on many occasions to make sure we were gonna get it right by our planning care by our mayor Mayor tourney even by our city engineer we had no option but to do it the way they wanted it. We were also told for months that the city Council would make the final vote and be able to overturn whatever we had done immediately following the vote the mayor walked up to myself so that's good it's a done deal we will not be sending it any further we just closed it out. Many council members knew we had all been told it would go to City but in fact it did not. I had a conversation with our chairman at the time at our car show at the park and he said that Courtney Justin and himself I've been working all week to come up with a way a loophole which is weird around this and that they thought they had one. There was no mention once they found the loophole of it going to cancel in a couple of weeks before the council would have actually voted that they had found this loophole and that we were the final people but we were told if we went outside of that we would be sued personally as well as planning commissioners. That all we could vote on is the LSD being within code and not what our citizens wanted. 





Figure 5 Eco-Vis Tontitowr Map Create FTN No. 08
