MOTION TO ADOPT AMENDMENTS TO REGULATION NO. 30

Comes now the Arkansas Department of Environmental Quality (ADEQ), by and through Kevin White, Associate Director for the Office of Land Resources, and for its Motion to Adopt Amendments to Regulation No. 30: Arkansas Remedial Action Trust Fund Hazardous Substances Site Priority List, states:

1. On October 27, 2017, the Arkansas Pollution Control and Ecology Commission (APC&EC or Commission) granted ADEQ's Petition to Initiate Rulemaking to Amend Regulation No. 30.

2. A public hearing was held at ADEQ Headquarters in North Little Rock, Arkansas, on December 4, 2017. No oral comments were made at the public hearing. The public comment period ended on December 18, 2017. No written public comments were received during the public comment period. ADEQ filed the Responsive Summary with the Commission on January 11, 2018.

3. The interim Senate Committee on Public Health, Welfare, and Labor and House Committee on Public Health, Welfare, and Labor met jointly and reviewed the amendments to Regulation No. 30 on February 5, 2018. A copy of the agenda from this meeting is attached as Exhibit A.

4. The Administrative Rules and Regulations Subcommittee of the Arkansas Legislative Council met, reviewed, and approved the amendments to Regulation No. 30 on May 15, 2018. A copy of the agenda is attached as Exhibit B.

5. ADEQ is filing its Statement of Basis and Purpose with the Commission as attached Exhibit C.

6. Pursuant to APC&EC Reg.8.814, ADEQ submits the following additional documents to support adoption of the regulation to the Commission for its consideration:

- a. Exhibit D – Final Proposed Regulation
- b. Exhibit E – Regulation Tracking Sheet
- c. Exhibit F – Proposed Minute Order

WHEREFORE, ADEQ respectfully requests that the Commission grant this Motion to Adopt Amendments to Regulation No. 30; adopt the Proposed Minute Order concerning the amendments to Regulation No. 30; and promulgate the revised regulation.
