Public Notice

Pursuant to the Arkansas Operating Air Permit Program (Regulation 26 of the Arkansas Pollution Control and Ecology Commission) Section 602, the Air Division of the Arkansas Department of Environmental Quality (ADEQ) gives the following notice:

Georgia-Pacific Crossett LLC (0200013) operates a facility located at 100 Mill Supply Road, Crossett, AR 71635. This facility has submitted an application to revise the Carbon Monoxide (CO) Best Available Control Technology (BACT) limit established for Tissue Machine No. 8 Burners (SN-79). The total permitted emission increases include 2.04 tpy of CO. The total permitted emission decreases include 0.6 tpy of Particulate Matter (PM), 0.6 tpy of Particulate Matter 10 micrometers or less in diameter (PM $_{10}$), 0.7 tpy of Volatile Organic Compounds (VOCs), 3.6 tpy of Oxides of Nitrogen (NO $_x$), and 0.16 tpy of Hexane.

The application has been reviewed by the staff of the Department and has received the Department's tentative approval subject to the terms of this notice.

Comments will be accepted in accordance with Section 8.208 of Regulation 8 of the Arkansas Pollution Control and Ecology Commission. During the public comment period, any person may submit written comments to the Department at the above address Attention: ADEQ Air Permits Branch or to airpermits@adeq.state.ar.us by email. The public comment period shall begin on April 27, 2016 and shall expire at 4:30 p.m. Central Time on May 27, 2016. However, additional comments will be accepted at a public hearing for the draft permit as listed below.

The ADEQ Director has decided to hold a public hearing for this permit on June 7, 2016 at 6:00 P.M. in the Municipal Auditorium at 1100 Main Street, Crossett, AR 71635. The purpose of the public hearing is to allow public participation in the determination of the terms and conditions of the final air permit. ADEQ technical staff will be available to informally discuss the draft permit. In addition, a hearing officer will accept formal public comments at the hearing. Verbal comments will be accepted, but written comments are preferred in the interest of accuracy. Comments will only be accepted during this hearing.

The Director shall make a final decision to issue or deny this application or to impose special conditions in accordance with Section 8.211 of Regulation 8 and Regulation 26.
