Dear Mr. Seitz:

On July 8, 2009, I performed an investigation of your gravel removal actions on the Kings River in response to a complaint in accordance with the provisions of the Arkansas Water and Air Pollution Control Act and the regulations promulgated thereunder. The complainant alleged that gravel was being removed from a Kings River island gravel bar upstream of the Grandview Bridge. This inspection revealed the following violation:

Removal of gravel from below the ordinary high water mark of the Kings River, an Extraordinary Resource Waterway, without authorization from the Department in violation of Arkansas Pollution Control and Ecology Commission Regulation No. 2.

The above item requires your immediate attention. Please submit a written response to this finding to Cindy Garner, Water Division Enforcement Branch Manager, of this Department. The response should be mailed to the address below. This response should contain detailed documentation describing the course of action taken to correct the item noted. This corrective action should be completed as soon as possible, and the written response with all necessary documentation (i.e. photographs) is due by August 15, 2009.

A site investigation was performed on 7/08/09. The investigation revealed that gravel had recently been removed from an island gravel bar of the Kings River, an Extraordinary Resource Waterway, just upstream of the Hwy. 143 bridge. The investigation revealed that gravel had been removed from an area approximately 45 yards by 8 yards since a previous investigation on 5/29/09.

This inspection revealed the following violation:

Removal of gravel from below the ordinary high water mark of the Kings River, an Extraordinary Resource Waterway, without authorization from the Department in violation of Arkansas Pollution Control and Ecology Commission Regulation No. 2.

The following violation was cited as the result of a May 29, 2009, investigation:

Removal of gravel from below the ordinary high water mark and operating equipment in the wetted portion of the Kings River, an Extraordinary Resource Waterway, without authorization from the Department in violation of Arkansas Pollution Control and Ecology Commission Regulation No. 2.
