

Dear Mr. Baker:

The following are in response to your comments dated November 18, 2013 concerning the above referenced permits.

- 1. We are requiring the contractor to install silt fencing in various areas until vegetation can be reestablished. Some of the areas will be sodded this week and others have been seeded and straw placed since your inspection.
- 2. The contractor periodically collects waste such as discarded litter, construction debris, etc. We are requiring the contractor to collect waste more frequently and thoroughly.
- 3. We are requiring the contractor to update the site plan included with the SWPPP with all BMP's used at the site.

The City of Bryant also intends to submit an application for a Short Term Activity Authorization for this project.
