The Department has issued the renewal of Stormwater Construction general Permit (ARR150000) with an effective date of November 1, 2011. If the project is complete and you wish not to renew your coverage, you must submit a Notice of Termination (NOT).

Permittees who fail to make a written request to the Director to be covered by this general permit by the January 31, 2012 will be operating without a permit which will be in violation of the Arkansas Water Pollution Control, Ark. Code Ann. 8-4-101 et seq.), and the Clean Water Act (33 U.S.C. 1251 et seq.). Failure to submit a NOT or Recertification NOI could result in enforcement action.
