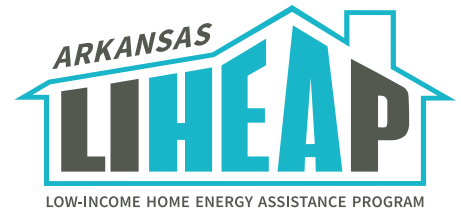


Do you need help paying your utility bills—cooling costs in the summer, and heating costs in the winter?



YOU MAY NOT HAVE TO GO IT ALONE.

STEP 1: Check to see if the TOTAL income for all household members is at or below the maximum monthly income limit.*

STEP 2: Find out which community-based organization (CBO) will help you, based on the Arkansas county where you live. Find the CBO contact information on the back of this handout.

WANT TO SAVE YOURSELF TIME AND ENERGY? WHO DOESN'T—RIGHT?

Your community-based organization (CBO) will provide you with the application and guide you through the process, but it will go a lot faster if you are prepared.

HERE'S WHAT THE CBO REQUIRES WITH YOUR APPLICATION:

PROOF OF IDENTITY

- A driver's license; **OR**
- Another government-issued photo ID

SOCIAL SECURITY INFORMATION

- **CARDS** for household members age 18 or older
- **NUMBERS** for household minors
 - BIRTH CERTIFICATES for infants age one or younger who have no Social Security number

PROOF OF INCOME**

- Employment check stubs from the month prior to application; **OR**
- Social Security or other benefit statement(s)

UTILITY BILLS

- Your most recent utility bills

LEASE AGREEMENT

- **IF** any utilities are included in your rent

Applies to **all household members age 18 or older.

WHEN CAN YOU APPLY?

LIHEAP applications are accepted for WINTER HEATING (primary and/or secondary heating fuel bills) and SUMMER COOLING (electricity bills) assistance on a first-come-first-serve basis. Contact your CBO for the dates LIHEAP is accepting applications.
