

CHAPTER SIX: ADMINISTRATIVE PROCEDURES LAKE MAUMELLE BASIN

Reg 6.601 Penalty Policy and Administrative Procedures Lake Maumelle Basin

The provisions of Regulation No. 7: CIVIL PENALTIES and Regulation No. 8: ADMINISTRATIVE PROCEDURES apply to this Regulation. All surface discharges of wastewater in the Lake Maumelle Basin are prohibited, with the exception of discharges permitted under the NPDES stormwater discharge program.

Reg.6.602 Severability

If any provision of this Regulation or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Regulation which can be given effect with the invalid provision or application, and, to this end, provisions of this Regulation are declared to be severable.

CHAPTER SEVEN: EFFECTIVE DATE ADMINISTRATIVE PROCEDURES

Reg. 6.701 Effective Date Penalty Policy and Administrative Procedures

This regulation is effective ten (10) days after filing with the Secretary of State, the State Library, and the Bureau of Legislative Research. The provisions of Regulation No. 7: CIVIL PENALTIES and Regulation No. 8: ADMINISTRATIVE PROCEDURES apply to this Regulation.

Reg. 6.702 Severability

If any provisions of this Regulation or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Regulation which can be given effect with the invalid provision or application, and, to this end, provisions of this Regulation are declared to be severable.

CHAPTER EIGHT: EFFECTIVE DATE
