Dear Members of the Arkansas Pollution Control and Ecology Commission,

The attached resolution is submitted on behalf of the Arkansas Audubon Society, a statewide organization committed to fostering a greater knowledge of the natural history of Arkansas and promoting conservation of natural resources in Arkansas. We present this resolution to demonstrate our support of the third-party rule proposed by the Ozark Society and Arkansas Public Policy Panel to prohibit the Arkansas Department of Environmental Quality from allowing future permits in accordance with Arkansas Pollution Control and Ecology Commission Regulation Numbers 5 and 6.

The Buffalo River is a state and national treasure. Since its establishment in 1972, countless people have relied on the river and surrounding region for recreation, a source of income, and a place to call home. The unique offerings of the area exist in large part due to the ecological diversity and integrity of the watershed. Concentrated animal feeding operations (CAFOs) threaten water quality via the disposal of their liquid waste through land application and surface storage, which can lead to contamination of nearby streams and rivers, especially in karst topography such as that surrounding the Buffalo River.

As such, we urge the APCEC to adopt the third party rule mentioned above in order to protect the waters, soils, plants, and animals that makes the Buffalo River an exceptional natural resource for people, plants, and wildlife alike.
