Arkansas Environmental Federation; The Federation's ultimate position is unknown, however, ADEQ is in communication with the Federation about any concerns with the proposed rule.

## **Summary of Proposed Rule**

ADEQ proposes to amend Regulation No. 2 to:

- (A) Add the definition of "Base-Flows" to Section 2.106;
- (B) Add the definition of "Escherichia coli" to Section 2.106;
- (C) Add the definition for "ground water under the influence of surface water" to Section 2.106;
- (D) Add the definition for "Storm Flows" to Section 2.106;
- (E) Update the reference to the Arkansas Natural Resources Commission in Section 2.203;
- (F) Changing the common name of the "Grass pickerel" to "Redfin pickerel" in Section 2.302(F)(3)(e) & (f);
- (G) Deleting "tracers used in hydrological studies" from the list of activities that require a short-term activity authorization in Section 2.305;
- (H) Adding language to Section 2.404, Mixing Zones, to protect domestic water supply intakes from mixing zones;
- (I) Replace term "Primary Values" with "Base-Flow Values" in Section 2.503, Turbidity;
- (J) Revise language related to maximum allowable levels of bacteria in primary and secondary contact waters in Section 2.507;
- (K) Revise 2.507(C) to clarify that *E. coli* will be used for ambient water quality assessment;
- (L) Delete Beryllium from the list of Human Health Criteria standards in Section2.508, Toxic Substances;

- (M) Delete language in Section 2.511, Mineral Quality to make the standard consistent with current assessment methodology;
- (N) Add Lost Creek Ditch (Cache River) to the list of streams with mineral standards in Section 2.511. This segment will have the same standards as Bayou DeView;
- (O) Add "Hurricane Creek" to clarify descriptions of two streams listed in Section 2.511; and
- (P) Revise the language of Section 2.511 regarding maximum naturally occurring levels of minerals as determined by the least-disturbed ecoregion reference streams.
