## Benefits of the Proposed Rule or Regulation

1. Explain the need for the proposed change(s). Did any complaints motivate you to pursue regulatory action? If so, Please explain the nature of such complaints.

Act 729 of 2005 made several changes to the wastewater licensing program followed by the Commission and by the Department. The Department proposed this rulemaking primarily to make the provisions of Regulation 3 conform with the statutory changes effected by the Act. The proposed regulatory amendments precipitated by Act 729 of 2005 involve devising a definite procedure for suspending or revoking a wastewater operator's license. ADEQ engaged in a review of the regulation and proposed changes to Regulation Number 3 which include the following:

- a. Table of Contents: Change the Title of 3.305 from "License Conversion" to "License Class Requirements";
- b. Chapter Three: Adding requirements for Apprentice Industrial Operator; Deleting requirements for License Conversion; Deleting references to the last regulation revision;
- c. Chapter Four: Adding clarification to the credit given for correspondence courses;
- d. Chapter Six: Adding clarification about information supplied in the exam application; Adding acts that are to be considered for license suspension or revocation.
- 2. What are the top three benefits of the proposed rule or regulation?
  - a. Adding definite procedures for suspended or revoked licenses;
  - b. Deleting procedures that no longer apply;
  - c. Clarifying correspondence course hours.
- 3. What, in your estimation, would be the consequence of taking no action, thereby maintaining the status quo?

Operators with suspended or revoked licenses would be able to renew or upgrade those licenses as if they were in good standing.

4. Describe market-based alternatives or voluntary standards that were considered in place of the proposed regulation and state the reason(s) for not selecting those alternatives. None

Yes, if exam application information submitted is falsified. Entry requirements for wastewater operators are not stringent. The concern is in setting a pattern for falsification of records.

No additional requirements for small business owners.
