- language under 6.207(A) specifying that "written and published notification would be issued no more than 30 days prior to submission of the NOI"
- that the Arkansas Dept. of Health be included in the list of entities to be notified
- that where a facility is to be located in the watershed of a national park the National Park Service be notified

In addition, with the goal to notify public citizens and stewards of our waters when permitting is being sought, we ask your consideration of an amendment to the proposed rulemaking as follows:

6.207(A) Friends of the North Fork and White Rivers requests an amendment to the proposed rulemaking to add the following text:

To provide *email* notice to persons who join a list serve requesting receipt of such notices. For instance a listserv such as WP-PendingNOIDaily@listserv.adeq.state.ar.us>

We concur with our friends at the National Park Service, and the Buffalo River Watershed Alliance that these amendments will better serve the public, private landowners, NGOs and the State and Federal lands within the State of Arkansas.
