## NOTICE OF PUBLIC HEARING

The Arkansas Pollution Control and Ecology Commission will hold a public hearing in Little Rock October 19, 2004, to receive comments on proposed changes to Commission Regulation No. 17, the Arkansas Underground Injection Control (UIC) Code. The hearing will begin at 2:00 p.m. in the Arkansas Department of Environmental Quality's (ADEQ) Building D training room, 8101 Interstate 30.

The Commission's authority for adopting and amending the regulation is found in Arkansas Code Annotated Section 8-4-101, et seq.

Most of the proposed changes to the regulation involve revising the regulation's format and structure to conform to the standardized format adopted for other Commission regulations, as well as the addition or modification of definitions to conform to federal regulation changes.

Proposed substantive changes to Regulation No. 17 include addition of language to clarify the shared role of the ADEQ and the Arkansas Oil and Gas Commission regarding the Arkansas UIC program, and addition of requirements for two new subcategories of Class V wells to be governed by Regulation 17. The new subcategories are large-capacity cesspools and motor vehicle waste disposal wells.

Copies of the proposed changes are available for public inspection during regular business hours at the ADEQ's Little Rock office in the Customer Service Division, located in Building D, 8101 Interstate 30, or ADEQ information depositories located in public libraries at Arkadelphia, Batesville, Blytheville, Camden, Clinton, Crossett, El Dorado, Fayetteville, Forrest City, Fort Smith, Harrison, Helena, Hope, Hot Springs, Jonesboro, Little Rock, Magnolia, Mena, Monticello, Mountain Home, Pocahontas, Russellville, Searcy, Stuttgart, Texarkana, and West Memphis; in campus libraries at the University of Arkansas at Pine Bluff and the University of Central Arkansas at Conway; or in the Arkansas State Library located on the State Capitol grounds at Little Rock. In addition, a copy of the regulation showing the proposed changes is available for viewing or downloading at the ADEQ's Internet web site located at <a href="https://www.adeq.state.ar.us">www.adeq.state.ar.us</a>.

Oral and written comments will be accepted at the hearing, but written comments are preferred in the interests of accuracy. In addition, written and electronic mail comments will be considered if received no later than 4:30 p.m. November 2, 2004.
