Nonattainment New Source Review Requirements and Regulation 19, Regulations of the Arkansas Plan of Implementation for Air Pollution Control, Chapter 12

Benefits of the Proposed Rule or Regulation

To meet the minimum federal requirements for new source review in nonattainment areas. The federal requirements are codified at 40 CFR 51.160 through 40 CFR 51.165. Regulation 19, Chapter 12 will be repealed and the provisions of Chapter 12, together with other federal requirements for new source review in nonattainment areas will comprise the new Regulation 31.
