The changes to Regulation No. 19 are being proposed in response to the United States Environmental Protection Agency's ("EPA") July 20, 2011, "Deferral for CO ₂ Emissions From Bioenergy and Other Biogenic Sources Under the Prevention of Significant Deterioration and Title V Programs, Final Rule." This Final Rule defers, until July 21, 2014, the application of PSD requirements to biogenic carbon dioxide ("CO ₂ ") emissions from bioenergy and other biogenic stationary sources. Language is being proposed in Chapter 2 to the definition of "CO ₂ equivalent emissions" ("CO ₂ e") and in Chapter 19, under 19.904(G)(2)(c), to include the deferral for CO ₂ emissions from bioenergy and other biogenic sources under the PSD Program.
