7. What is the purpose of this proposed rule? Why is it necessary?

*The substantive changes to Regulation No. 19 are being proposed in response to the United States Environmental Protection Agency's ("EPA") July 20, 2011, "Deferral for CO<sub>2</sub> Emissions From Bioenergy and Other Biogenic Sources Under the Prevention of Significant Deterioration ("PSD") and Title V Programs, Final Rule." This Final Rule defers, until July 21, 2014, the application of PSD requirements to biogenic carbon dioxide ("CO<sub>2</sub>") emissions from bioenergy and other biogenic stationary sources. Language is being proposed in Chapter 2 to the definition of "CO<sub>2</sub> equivalent emissions" ("CO<sub>2</sub>e") and in Chapter 19, under 19.904(G)(2)(c), to include the deferral for CO<sub>2</sub> emissions from bioenergy and other biogenic sources under the PSD Program.*

*One change to Regulation No. 19 is being proposed to clarify the applicability of the "stay" provision. It is proposed that this provision be moved (without revision) from 19.904(G)(6) to the Severability section found at Reg. 19.104.*
