The Department expects to receive comments from stakeholders (specifically owners and operators conducting demolition and/or renovation activities), air monitoring inspectors, construction developers, designers or any person conducting management or disposal of asbestos-containing material record keeping, interested in training provider licenses and documents required for certifications or renewal of licenses. This proposed rulemaking is the result of an extensive two-year collaborative effort between the Department and stakeholders, including public meetings from which currently proposed revisions were taken. The Department provided responses to public concerns which were raised in these meetings and maintained an online listserv for interested parties involved throughout the drafting process. However, the overall consensus on this proposed rule is unknown at this time.
