The changes to Regulation Number 26 are being proposed in response to the United States Environmental Protection Agency's ("EPA") July 20, 2011, "Deferral for CO <sub>2</sub> Emissions From Bioenergy and Other Biogenic Sources Under the Prevention of Significant Deterioration and Title V Programs, Final Rule." This Final Rule defers, until July 21, 2014, the application of the Title V permitting requirements to biogenic carbon dioxide ("CO <sub>2</sub> ") emissions from bioenergy and other biogenic stationary sources. Language is being proposed in Chapter 2 to the definition of "CO <sub>2</sub> equivalent emissions" ("CO <sub>2</sub> e"), to include the deferral for CO <sub>2</sub> emissions from bioenergy and other biogenic sources under the Title V Program.
