Questions\_Comments:

As an environmental consultant, I work throughout the USA. Your Environmental Professional (EP) Certification regulations are nothing more than protectionist legislation and a means to shake down the EP for cash. I have no problem with the Federal standard in AAI which defines an EP. That should suffice for any Phase I performed in Arkansas. I can see a difference in drilling and sampling requiring a PE or PG registered in any state. The State of Arkansas has found a way to get \$200 from the environmental consultants across the USA. The last thing we need are more restriction and more regulations in an area that is already difficult to make a living in. In addition 60 days is way too long for the process. When I get an assignment, I have less

than 1 week to look at the site. This slow process is typical of a State agency that they can't process a simple form in a week but needs 60 days. State Agencies need to wake up and try working for a living like the rest of us.

ADEQ responds that the revisions to Regulation No. 32 proposed in this rulemaking will eliminate the burdensome requirements of which the commenter complains.

Internal review: In internal review and editing of the draft Regulation, the language at Section 32.607(A)(3) was stricken. This provision would require that an environmental professional's certification of an assessment report would need to include his or her certificate number. As the Department will no longer be issuing numbered certificates, or certificates under this program, there is no need to require that an EP provide a state or other certificate number. This revision does not substantively affect the scope and intent of these proposed revisions.
