APC&EC adopted this emergency rulemaking to provide the framework necessary for ADEQ to transfer the current waste tire program to the new Used Tire Recycling and Accountability Program pursuant to Act 317 of 2017, the Used Tire Recycling and Accountability Act, Ark. Code Ann. \$ 8-9-401 *et seq*.

The proposed new emergency regulation includes the following necessary for the transfer of the current waste tire program to the new Used Tire Recycling and Accountability Program by ADEQ on January 1, 2018:

• General overview, purpose, legislative intent, authority, and applicability related to the Used Tire Recycling and Accountability Program;

- Definitions related to the administration of the Used Tire Recycling and Accountability Program;
- Electronic uniform used tire manifest system (e-manifest system) purpose and administration;
- Used tire program accountability and business plans administration;
- Administrative procedures for tire generators;

• Collection of rim removal fees, commercial generator fees, and import fees and submission to the Department of Finance and Administration and the Arkansas Department of Environmental Quality for deposit into the Used Tire Recycling Fund; and

• Disbursements from the Used Tire Recycling Fund.

Pursuant to Arkansas Pollution Control and Ecology Commission Regulation No. 8.807, the Arkansas Department of Environmental Quality (ADEQ) seeks an emergency rulemaking, effective for one hundred eighty (180) days, because transfer of the current waste tire program to the new Used Tire Recycling and Accountability Program must begin on January 1, 2018, and permanent rulemaking cannot be completed before this date. Failure to implement the new regulation will cause imminent peril to the public health and general welfare of Arkansans because the regulation provides essential information for the implementation and administration of the new program, to include the methods for disbursing essential funding to regional solid waste management boards for the management of used tires, the prevention of illegal tire dumping, and the abatement of waste tire sites.
