KNOW ALL PERSONS BY THESE PRESENTS:

WHEREAS, under the provisions of A.C.A. § 8-9-401, et. seq. (the Act) and Arkansas Pollution Control and Ecology Commission Rule 36 (the Rules), every used tire licensed transporter described therein must obtain a corporate surety bond or cash bond to comply with the Act and the Rules;

WHEREAS, every transporter is required to comply with all provisions of the Act and the Rules while operating in the State Arkansas:

as Surety, are held firmly bound to the Arkansas Department of Energy & Environment, Division of Environmental Quality (DEQ), as Obligee, in the penal sum of Ten Thousand Dollars (\$10,000) for payment of which we bind ourselves, our heirs, assigns, executors and administrators, jointly and severally, for any claims arising out of or related to Principal's failure to strictly comply with Act or the Rules.

If Principal shall promptly pay all amounts due to DEQ, and in all respects strictly comply with the Act and the Rules, then this obligation shall become void, otherwise to remain in full force and effect.

The Surety may cancel the bond by sending written notice of cancellation by certified mail to the Principal and to the DEQ Director at least sixty (60) days in advance of cancellation.

For any and all disputes arising out of, in connection with, or relating to this Surety Bond, the Principal and Surety expressly agree and consent that the exclusive jurisdiction and venue for any proceeding shall be in Pulaski County Circuit Court for the State of Arkansas in Little rock, Arkansas, and the Principal and Surety waive any argument that the venue in such a forum is not convenient and any rights under any Federal or State law establishing jurisdiction or venue in another forum.
