I am pledging to start doing my part by making my voice heard, voting wisely, and giving my dollars to those that are working to save the river. I hope you will join me in monitoring those in power by letting them know we will no longer accept them sacrificing the future of our natural state for the short monetary gain of the present. Who can quantify the price in dollars of such a national treasure? Please save the Buffalo River.
